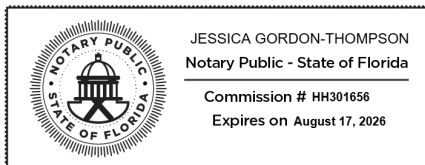

The Board of Commissioners' November 17, 2025 decision approving the application was appealed to the Oregon Land Use Board of Appeals in LUBA No. 2025-082. On December 16, 2025, the Board of Commissioners voted to withdraw its decision for reconsideration pursuant to ORS 197.830(13)(b). The Applicant is Jeffrey G. Condit, Miller Nash LLP on behalf of Republic Services. The Property Owner(s) are Valley Landfills, Inc. The Zone Designations are Landfill Site (LF) and Forest Conservation (FC), and the Comprehensive Plan Designation is Landfill Site (LF) and Forest (F). The application proposes to expand the Coffin Butte Landfill to authorize landfill uses and associated development, including development of an 1,800 sq. ft. employee building with off-street parking, modification of an access road, development of leachate ponds, an outbound scale, and construction of a shop/maintenance area. The applicant is also proposing to modify access roads North of Coffin Butte Road. The Property is located at 29175 Coffin Butte Road, Corvallis, Benton County, OR 97330.

The Planning Commission initially denied the application, and the Applicant filed an appeal.
