As someone who has spent many years leading the Albany Area Chamber of Commerce and working closely with local businesses, I have seen firsthand how essential Coffin Butte is to the economic health and stability of our region. Businesses and residents across Linn and Benton counties depend on reliable, affordable solid waste services to operate efficiently and plan for the future. Without local capacity, those costs rise quickly — and that affects everything from small business budgets to household expenses, school districts and public services. Coffin Butte is an integral part of the region's infrastructure. Each year, the facility safely manages a significant portion of the solid waste generated by Benton and Linn County communities, including Albany. Its continued operation supports local jobs, contributes millions in economic impact, and helps maintain the affordability of services that businesses and families count on every day. I've also seen Republic Services' role as a community partner — one that invests in local priorities and responds to feedback. The company's \$250,000 contribution to the adaptive playground at the Mid-Willamette Valley YMCA is one example of its commitment to improving quality of life. More recently, the company revised its expansion proposal to reduce its duration and preserve public access to Coffin Butte Road — actions that reflect a willingness to listen and collaborate. My name is Rob Thompson and I am the owner and president of Thompson's Sanitary Service in Newport. We are the family-owned and family-operated collection and recycling company serving Newport for over 60 years and counting. I am writing today to provide context and gather support from Lincoln County citizens regarding the recently denied expansion of Coffin Butte Landfill. All waste collected by Thompsons is disposed of at Coffin Butte Landfill. If Coffin Butte is no longer available, Newport's waste will be transported to other sites that are much further away (likely Arlington or Medford). This will have a significant impact on rates for residential and commercial customers, and at our local transfer stations. Make no mistake, Benton County's mistake of denying the expansion will be paid for from the pockets of Lincoln County's residents. Our mission at Thompsons is to guide sustainable choices. Coffin Butte is heavily regulated and monitored and provides the most environmentally conscious option for our local waste. Trucking waste further creates additional transportation emissions, with no beneficial impact on reduction in waste generation. It pushes our responsibility of our waste onto someone else's environment and community. It fails the test of the environmental justice lens. I encourage all residents of Newport and Lincoln County to stand up and join the coalition to safeguard our environment, and ensure
