Chair and Commissioners,

The Employees of Thompson Sanitary Service that have signed below appreciate the opportunity to provide testimony in strong support of the conditional use permit for the Coffin Butte Landfill expansion.

Thompson Sanitary Service has served Lincoln County and the greater Central Oregon Coast for generations. Our work depends on reliable, affordable, and efficient waste disposal infrastructure to keep our communities clean, our businesses operating, and our customers' costs manageable. Coffin Butte Landfill is the cornerstone of that system.

If the landfill cannot expand, and waste must be transported to more distant facilities, the consequences will be significant and far-reaching:

- **Transportation Costs:** Every additional mile adds fuel, maintenance, and labor expenses. These costs compound quickly for hauling companies like ours and ultimately flow down to households, small businesses, and local governments already struggling with inflation and high living costs.
- **Environmental Impact:** Longer hauls mean more trucks on the road, more emissions, and greater wear on Oregon's already stressed highway infrastructure.
- **Regional Strain:** There is no nearby alternative capable of absorbing the volume currently managed by Coffin Butte without driving up prices and creating service disruptions across western Oregon.

For the coast and the surrounding regions, Coffin Butte is not a luxury—it is an essential piece of public infrastructure. It allows us to manage solid waste responsibly, sustainably, and cost-effectively. The expansion would make use of existing infrastructure and proven management practices while providing the time and stability needed to develop future waste reduction and recycling innovations.

Our company believes that responsible planning means balancing long-term sustainability with present-day realities. Refusing expansion does not solve our waste challenges—it simply pushes the problem farther away, at a higher cost to the customers we serve every day, as well as other numerous Oregon families and businesses.

We urge you to approve this permit and allow Coffin Butte to continue serving as a reliable, well-managed regional facility that supports the economic and environmental health of our communities.
