NOTICE OF DECISION

On July 22, 2025, the Planning Commission deliberated and voted 7-0 to deny the Conditional Use Permit application. On July 29, 2025, the Planning Commission voted to adopt the final written decision and findings of fact and conclusions of law in support of its decision to deny the application. Copies of the Findings of Fact are available for inspection on the Community Development Department's website.

The Planning Commission's decision may be appealed. A person may appeal a decision of the Planning Commission to the Board of Commissioners if while the record was open the person provided written or oral testimony to the Planning Commission regarding the decision. An appeal of a decision of the Planning Commission shall be filed within 14 calendar days from the date of final decision. An appeal shall be filed with the Planning Official no later than 5:00 p.m. on the final day of the appeal period. The appeal must be filed in writing on the form provided by the Planning Official, and shall include: (1) A statement of the reasons for the appeal, citing the specific Comprehensive Plan or Development Code provisions which are alleged to be violated; (2) A statement of the standing to appeal; and (3) Payment of the filing fee established by order of the Board of Commissioners.

Attached here (or [available here](#) in the LU file in our dept drive) is the final list of folks who submitted public comment on this LU case beginning 1/1/25. Here's a quick overview of what we did:

Note: Each worksheet is password protected to reduce the possibility of accidentally typing in a cell. The password is either "Shannon" or "sHANNON" (since I had caps lock on periodically).

- Per your suggestion, the planning team assumed the docs posted on MuniDocs (specifically, folder #s [7](#), [9](#) and [10](#)) serve as the most complete accounting of public comments received for this application. As such, yesterday, we went through all these folders and the documents within and pulled out a complete record into Excel, including: sender name, date received, email address, complete mailing address, and a numbered ID was assigned. I also added in the records from the 2 verbal testimony sign-up sheets, so those folks' contact info are also included in this master list of all public commenters. This exercise resulted in a total of ~1400 records.

Complete Record for Future PRR:

- o See worksheet titled, "**Original for PUB RECORDS RQST**". My intent here was to create a complete list of all commenters (*not what was said, just who participated and contact info*) - without formatting or anything applied yet. Not sure if we or the consulting team already have something created for this purpose, but thought it may be useful later.

Email Notification of Notice of Decision (NOD):

- Next, I copied that "Original..." sheet and sorted it on Name & Email address, then applied conditional formatting to identify duplicates (shown in red).
 - o See worksheet titled, "**1. Sorted Name&Email, Dupes.**" This worksheet maintains all 1400 records, just with formatting added.
- Next, I copied that "1. Sorted Name&Email..." worksheet and used Excel's "Remove Duplicates" function **to remove duplicate instances of emails only**. This resulted in a total of 678 unique email addresses.
 - o See worksheet titled, "**2. EMAIL DUPES REMOVED.**"
 - **Column D of this worksheet is the list of emails you will want to use in our emailed version of the Notice of Decision.**

Mail Notification of NOD:

- Next, I copied the "Original..." spreadsheet and sorted it on Name & Mailing address, then applied conditional formatting to identify duplicate sender names and mailing addresses (shown in red).
 - o See worksheet titled, "**3. Sorted Name&Addy, Dupes.**" This worksheet maintains all 1400 records, just with formatting added.
- Next, I copied that "**3. Sorted Name&Addy...**" worksheet and used Excel's "Remove Duplicates" function to remove duplicate instances of sender names & mailing addresses combined. Then, I went through this

list of 900+ records with a fine tooth comb (my eyes actually HA) and removed instances where minor differences in address were creating duplicates (i.e., “Drive” vs “Dr.” vs “Dr”). I also filtered out records without a complete mailing address. This resulted in a total of 626 unique records.

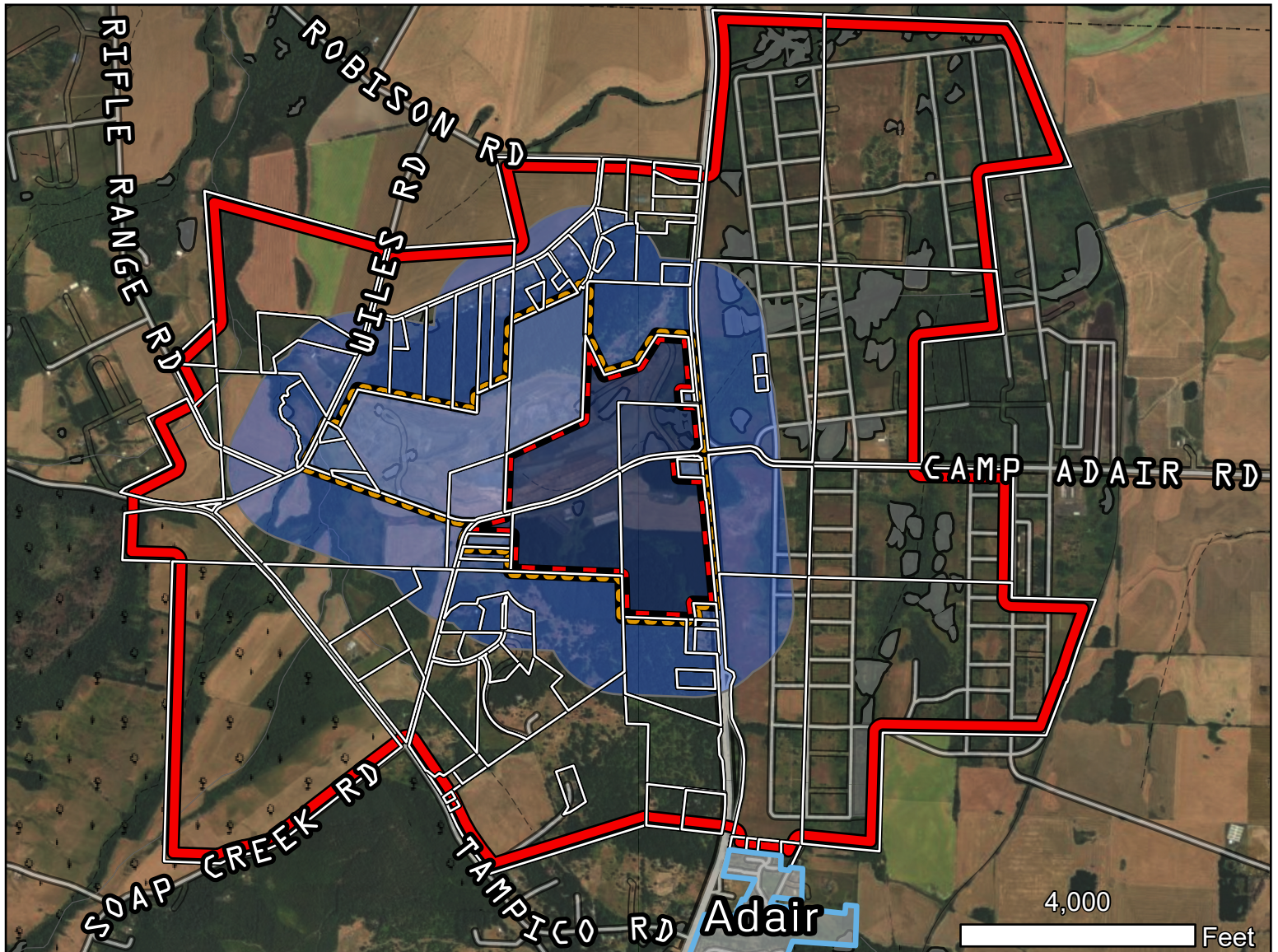
