## Public Comment Application LU-24-027. ConditionalUse Permit Application for Coffin Butte Landfill

I oppose the conditional use permit (CUP) application for the proposed use permit because it seriously interferes with the uses of adjacent properties. As I understand it, any approval of this land use application would have to come from yhour judgement that th4e expanded landfill would NOY seriously interfere with uses on adjacent property, with the character of the area or the the purpose of the zone.

The Benton County Comprehnsive Plan promoted a statewide goal to including, "to aintain and improve the quality of the air, water and land resoiurces of the state; to protet people and property from natural hazards; to maintain and improve the variety of economic and social activities that are vital to the health, welfaire, and prosperity of Oregon's citizens."

Our family moved down the road from the dump 26 years ago when the landfill wasn'tfairly small. We bought a house with acreage and put much love, care and effort into making it our home over the years!. We restored the property, which had been logged and over grazed and covered with black berry vines. The house and little cow shed were unattractive. With constant effort, love and money we changed our beloved property from an ugly, logged, overgrazed pasture with a run down cow shed, to a retored wetland, boardering Soap Creek, a vibrant pasture and a barn with a new roof. We replanted acres of trees and established a yard and garden.

26 years ago, the house was dated and unfinished. It now has all new windows, roof, deck, floors, carpets, paint, skylights, doors, and more. It isn't a showplace. It is a HOME in the happiest sense of the word. Every change was lovingly thought out. Our daughter, who grew up here, would like to have her family grow up here when we move on.

But wait! The stench of the nearby landfill sometimes permeates the air! The leachate is poisonous to the air and land and water! Not only will our land be unsafe, and our ability to enjoy hiking, bicycling and horseback riding be unavailable, and also, the value of our house property will be much, much less! Our beautiful country home willmean very little.

The changes to the landfill are in violation to rules: BCC53.215 (1) Very little is monitored in it's daily addition of poisonous and unnecessary waste.

Also, the statewide goals promoted in the Benton County Comprehensive Plan include "to maintain and improve the quality of the air, water and land resources of the state, to protect people and property from natural hazards, to maintain and improve the variety of economic and social activities that are vital to the health, welfare, and prosperity of Oregon's citizens."

However, now in the early hours of the morning we hear large trucks as they dump their loads at the landfill. The kingfisher hasn't been much of a presence lately.
