Analysis of Shared Information During Land Use Process The report's release during the Conditional Use Permit (CUP) process is strategic:

Proactive Transparency: Sharing operational data upfront may preempt criticism or misinformation, building trust with regulators and the public.

Risk Mitigation: Addressing past issues (e.g., arsenic, OSHA citations) head-on demonstrates corrective action, reducing potential opposition.

Persuasive Element: By framing the expansion as essential for "continuous, safe, reliable, and affordable disposal," the report positions the CUP as a necessity rather than an option.

## Key Considerations:

Balance: The county must assess whether the report provides unbiased data or leans toward advocacy. For example, the arsenic memo (Appendix D) is defensive, emphasizing natural background levels without independent verification.

Precedent: Allowing applicants to share polished reports during land use reviews isn't uncommon, but it raises questions about equity (e.g., smaller businesses lacking resources to produce similar materials).

## Final Assessment

The report is primarily a transparency tool with secondary advertising undertones. Its posting is appropriate for public review but should be critically evaluated by the county and community to separate factual data from promotional messaging. For true equity, Benton County could consider:

Requiring all CUP applicants to submit standardized operational reports.

Providing neutral summaries of technical data to ensure accessibility for non-expert residents.

Hosting public forums where the report's claims can be questioned independently.

In essence, the report is both informative and strategic, typical of corporate communications in regulatory processes. Scrutiny is warranted to ensure the CUP decision is based on merit, not presentation.

Based on the 2023 Coffin Butte Landfill Annual Report and related context from search results, here is an analysis of its value considering incompleteness, age (as of July 15, 2025), and operational context:

1. Transparency Value vs. Strategic Advocacy

Basic Operational Disclosure: The report provides standardized data on landfill capacity (e.g., 12.9 years remaining as of June 2024), environmental monitoring (PFAS, arsenic, methane), and complaint logs 511. This fulfills regulatory reporting requirements and offers baseline transparency.

Expansion Justification: Republic Services explicitly uses the report to justify its 2024 Conditional Use Permit (CUP) application, emphasizing "urgent capacity limits" (8 months left in active cells) and a "50% smaller expansion" than the rejected 2021 proposal 610. This frames the report as a lobbying tool during active permit deliberations.

Omission of Critical Context: The report lacks discussion of major controversies, including a 2022 EPA methane leak investigation (where leaks exceeded instrument measurement capacity) 13 and community disputes over data accuracy. This selective presentation undermines its objectivity.

2. Limitations Due to Incompleteness

Missing Appendices: Key sections referenced in the report (e.g., full Annual Environmental Monitoring Report, leachate data) are noted as "on file at Benton County Health Department" but not publicly accessible 11. This limits independent verification.

Unaddressed Regulatory Actions: While the report states no permit violations occurred in 2023, it omits that Oregon's SB 726 (2025) imposed landfill-specific methane monitoring laws targeting Coffin Butte 6, suggesting unresolved compliance issues.

Incomplete Community Feedback: The "Summary of Customer Complaints" shows minimal odor reports (1 in 2023), but DEQ records indicate 9 odor complaints filed with regulators the same year 11 – a discrepancy unexamined in the report.

For Benton County to make informed decisions, real-time data (e.g., 2025 DEQ inspections, independent audits) and community-verified reports are essential.
